As the chamber referenced in its December issue of *Business Perspectives*, 2016 is shaping up to be a year full of battles for business during the short legislative session and at the ballot box. With a number of initiative petition having already been filed and more expected, the attack on Oregon's private-sector employers has begun.



At the chamber's January 11 membership meeting, the spotlight will be on Initiative Petition 28, an attempt to increase taxes on the gross revenue of Oregon's C-corps. Members may recall from the December story that IP28 if passed, would represent the largest tax increase in Oregon history

During the 2016 Oregon legislative session, the Roseburg Area Chamber of Commerce anticipates hosting two conference calls with the five members of our delegation. These conference calls are an incredible opportunity for our members to hear firsthand about what's happening in Salem during the session and to be sure our delegation is aware of local business positions on potential legislation. The calls are held in the chamber conference room. and make our state one of the worst states in the country to do business. According to the nonpartisan Legislative Revenue Office, IP28 is anticipated to generate \$5.3 billion every biennium, an increase to the state's General Fund budget of nearly 30%.

IP28 will essentially impose a 2½% gross receipts (sales) tax on most corporate sales above \$25 million in the state, in addition to other business taxes. Because the tax is on gross sales and not profits, businesses would be forced to pay the tax whether they make a profit or not. This proposal also unfairly harms hundreds of businesses with high sales and low profit margins such as grocery stores, construction businesses, automobile dealers, restaurants, pharmacies, hardware and other retail stores, a number of industrial/manufacturing companies and many others.

Speakers on the program topic will be a representative from Grow Oregon NOW, a coalition opposing IP28 and local or regional business representatives.



Leadership Class Selects Project

Each year the Roseburg Area Chamber of Commerce's Project Leadership class selects a community project that gives them the opportunity to take on leadership roles in the planning, funding and implementation of a project that impacts the well-being of Douglas County residents.

This year's Project Leadership participants are collaborating with South Umpqua High School, which proposed a project to enhance and beautify the school in celebration of its upcoming 50th anniversary. Specific activities will include adding seating areas in front of the school, benches outside the locker rooms to provide a meeting place, painting the school logo on the main building and the back of the building facing the I-5 corridor, and landscaping projects which will include a sun dial memorial.

The chamber's leadership class has already formed teams to complete the project by May 2016. The class will be collecting tax-deductible donations over the next five months to make this project a reality.
